MHR Announces Business Transfer of Asset Management Company

Mori Building Investment Management Co., Ltd. (MIM), to which the asset management of Mori Hills REIT Investment Corporation (MHR) is consigned, resolved at their Board of Directors Meeting held today to transfer part of its operations to Mori Building Real Estate Investment Advisory Co., Ltd. as of November 1, 2007. The business to be transferred is the "advisory business regarding investment concerning specified assets" (Article 34-10, Section 1, No. 4 of the Investment Trusts and Investment Corporations Law and Article 38 of the Law's enforcement ordinance) (hereafter, "Advisory Business." In addition, MIM filed with the Financial Services Agency on August 3, 2005 to operate the Advisory Business as a subsidiary business). The specifics are as follows:

1. Reason for Business Transfer

MIM has conducted the Advisory Business as a subsidiary business, but has decided to transfer the business in order to concentrate on the management of investment corporation assets as an asset manager.
